- c) Surety Bonds in prescribed proforma - 2 Nos.from two employees of UCIL(each on non-judicial stamp paper of Rs.20/-)




Formalities to be complied with :-

- a) House Building Plans as well as specifications and estimates of the proposed construction together with certificate from a qualified Civil Engineer confirming the estimated cost of the proposed construction - 2 copies. If the land falls in Municipal/N.A.C., permission of Competent Authority to construct Buildings as per approved plan are also required.
- b) Agreement in prescribed proforma - 1 No.(on non-judicial stamp paper of Rs.20/-)
- c) Surety Bonds in prescribed proforma - 2 Nos.from two employees of UCIL(each on non-judicial stamp paper of Rs.20/-)
- d) Mortgage Deed delivering the Title Deed in prescribed proforma - 1No.(on non-judicial stamp paper of Rs.20/-)
- e) Original Title Deed (not certified copy) together with Mutation Certificate, Non Encumbrance Certificate, Location of plot on trace paper and Revenue Receipt for release of House Building Advance.
- f) Photocopy of Salary Slip of last six months .

Management has discretion to undertake inspection at any stage of the construction undertaken by employees in doubtful cases.
