1. Scope of Work:

Labour supply of **08 (Eight)** manpower / day (**04 nos. in A shift + 04 nos. in B shift**) for Charging of Silex and pebbles in Ion Exchange Vessel in Turamdih Mill as required on day to day basis. Silex & Pebbles of approximately 6.5 MT weight along with 10 Cubic meter of Resin are to be pulled from the godown & charged in an Ion Exchange Vessel through an opening in the column. The job shall be carried out in two shifts e.g. A and B only. In each shift, **Four** persons are required on regular basis to complete the job as scheduled below:

2. Period of Completion:

The job requires replacement and charging of silex & pebbles in Twelve such Ion Exchange Vessels in a year. The completion period of the job for replacement and charging of silex & pebbles in **one vessel is ten days**. The nature of the job is "as & when "required basis. The Contractor shall be well informed seven days in advance about the forthcoming requirement of silex charging in a particular vessel so that he can arrange gate passes for the manpower to be deployed. The offer must be valid for one year from the date of placement of Work Order.

3. Working period & Responsibility:

6.00 A.M. to 2.00 P.M. & 2.00 P.M. to 10.00 P.M. on all working days. The job to be carried out will be explained to the contractor or his supplied manpower at the beginning of the contract & they will be responsible for carrying out the assigned quantity of work.

4. Payment:

11 (Eleven) R.A. bill and 01 (one) Final bill shall be paid.

5. Insurance:

You have to arrange Insurance coverage for manpower engaged for the work.

6. Gate Pass:

Bidders have to arrange gate pass on their own for 10 (Ten) persons at least so that full quota of manpower (08 Nos.) could be supplied Daily during the entire job.

7. Award of contract:

Contract for labour supply will be fully awarded to L1 bidder.

8. Penalty:

Penalty will be imposed on pro-data basis for short supply of manpower than desired 08 (Eight) manpower on day-to-day supply as below:

- i. Up to 08 manpower supplied – No penalty.
- ii. Manpower supplied below 08 & up to 06 → **Penalty of 15% of the offered cost per manpower.**
- iii. Manpower supplied below 06 & up to 04 → **Penalty of 20% of the offered cost per manpower.**
- iv. Manpower supplied below 04 & up to 02 → **Penalty of 25% of the offered cost per manpower.**

9. Rejection of Contract:

If concerned Engineer-in-Charge finds that jobs are not being done properly and there are slackness in work or progress is not satisfactory, then reminder shall be issued to the party for the improvement and even then if not improved then contract shall be cancelled.

10. Discrepancies and Adjustment of Errors:

- a) If there are varying or conflicting provisions made in any one document forming a part of the Contract, the accepting authority shall be the deciding authority with regard to the intention of the document.
- b) If on check there are found to be difference between the rates given by the Contractor in words and figures or in the amount worked out by him in the schedule of quantities and general summary the same shall be adjusted in accordance with the following rules:
 - i) In the event of discrepancies between description in words and figures quoted by a Tenderer, the description in words shall prevail.
 - ii) In the event of error occurring in the amount column of schedule of quantities as a result of wrong extension of the Unit rate and quantity, the Unit rate shall be regarded as firm & extension shall be amended on the basis of the rate.
 - iii) All errors in totaling in the amount column and carrying forwarded totals shall be corrected.

Safety:

You have to arrange one supervisor having knowledge of industrial safety to look after the entire job safely & satisfactorily. You have to arrange all tools & tackles at your own cost like shovels, Gumboot, Gloves, Helmets, Goggles, Respirator etc. to all the persons engaged daily.

Firm Price:

Price quoted shall remain firm till the completion of the work.

Rules and Regulations:

You have to follow all security, safety and labour rules of the Corporation.

Security Deposit:

You have to submit an amount equivalent to 5% of the awarded value of the work as security deposit in form of Demand Draft in favour of UCIL payable at State Bank of India, Jaduguda.

Start up work:

Within 10 (ten) days of award of work order.
