

ADMISSION NOTICE FOR CLASS XI

Applications are invited for admission in the following streams for the academic year 2020-21.

- 1) Science stream with subject combinations:
 - (a) English, Physics, Chemistry, Mathematics and Computer Science
 - (b) English, Physics, Chemistry, Computer Science and Hindi
 - (c) English, Physics, Chemistry, Mathematics and Biology
 - (d) English, Physics, Chemistry, Biology and Hindi
- 2) Commerce stream with subject combinations:
English, Hindi, Economics, Business Studies and Accountancy
- 3) Humanities stream with subject combination
English, Hindi, Economics, geography and History

General Eligibility – Passed / Qualified class X from a recognized board.

Note – Admission will be granted as per the availability of seats according to the merit. In case of a tie, marks obtained Science, Maths & English will be considered. If the tie still persists, the older candidate will be given preference.

The information given by the candidate in the online form submitted will be verified with their original documents at the time of admission. If found incorrect, the admission shall stand cancelled

Documents to be submitted at the time admission :

1. A passport size photograph to be pasted on the admission form.
2. Photocopy of the mark sheet / print out of marks statement can be downloaded from CBSE website.
3. Caste certificate (SC/ST) from the competent authority (SDO / Tehsildar) will be acceptable only.
4. T.C duly countersigned by DEO/ appropriate authority (in case of school affiliated to other than CBSE) needs to be submitted during admission
5. Undertaking by self and by UCIL employee (Annex-1 & Annex -2) in case of Non-DAE applicants must be submitted to declare for payment of fees on time & that in case they fail to pay the fees before the due date, the same amount shall be deducted from his / her salary.

Note:

1. Preference will be given to DAE wards & students under TNP/ SEEP.
2. Admission under Non-DAE category shall be at the discretion of the management and subject to availability of the seats only.
3. Non-DAE students shall be defined and restricted to the pass out of AEC Schools and discretion of UCIL management only when seats are still vacant.
4. Admission of the Non-DAE applicant irrespective of schools from which they passed out shall be treated as new admission.
5. An undertaking by the parents must be submitted as given below. "I am not going to claim any concession. This will be treated as new admission and revised fee shall be paid accordingly as prescribed for Non-DAE applicant." I shall pay the amount for the whole year at the time of admission. Form of undertaking 1 & 2 for Non-DAE applicants shall be available from the school office.
