Bidder should submit the proof of supply of THEJO/REMA TIP TOP make cold vulcanizing solutions as one order (for a value minimum of Rs.2.40 lakh rupees) or Annual rate contract (for a value minimum of Rs.2.40 Lakh rupees) with any of the companies during current/last three financial years, failing which offer shall be rejected.
