You are requested to submit sealed quotation in duplicate for “**Complete Rewinding and Repairing of Submersible Pumps of Turamdih Mill**” as per enclosed schedule of jobs (Schedule-A containing one page).

The submersible pumps may be inspected by bidders prior to submission of their offer at Turamdih Mill.

Scope of job:

The above job shall include complete dismantling, stripping of burnt coils of submersible pumps, cleaning, rewinding, varnishing, replacement of defective bearings, oil seal and mechanical seal, impeller or any other defective part, re-assembling, overhauling, painting (if required) and testing of rewound and repaired submersible pumps. All items needed for carrying out the above jobs shall be in the scope of the bidder. Nothing shall be issued by the corporation for this job.

Terms and Conditions:

Rate:

The offered rate shall be inclusive of service cost, material cost, rebate for burnt copper windings etc. and all taxes including G.S.T. The quoted rate shall be firm for this job and no escalation shall be permitted.

Validity:

The offer shall be valid for 90 days from the date of submission.

Payment

- 80 % Payment shall be made within 30 days of supply of repaired submersible pumps.
- 20 % Payment shall be made within 30 days of successful trial at our site.

General:

- 1) Submersible Pumps as a whole shall be delivered at your site.
- 2) Safe loading and unloading of Submersible Pumps shall have to be arranged by you at your site.
- 3) The transportation of Submersible Pumps shall be arranged by UCIL upto a distance of 25 kms. However, if the Contractor's workshop is located beyond 25 kms from Turamdih, then the to and fro transportation of the submersible pumps from Turamdih Mill shall be arranged by the contractor at free of cost. No extra claim shall be entertained. Transit Insurance or any other levy, dues etc. required for transportation shall be in contractor's scope in such case.
- 4) **The rewind and repaired submersible pumps shall have to be guaranteed for a period of 180 days from the date of delivery.**
- 5) The submersible pumps shall be overhauled, dismantled and assembled by you to carry out the jobs. The submersible pumps after rewinding and repairing by you at your site will be tested and accepted only after satisfactory trial.
- 6) Rewinding wires, insulating Materials, spare parts etc. to be used shall be of reputed make. Bearings shall be of SKF/FAG make only.
- 7) The burnt coils/windings may be kept by the bidder and rebate for the same shall be considered in the offered rate for the above job of rewinding of submersible pumps.
- 8) **Completion Time: 02 (Two) months**
- 9) **Liquidated Damages (LD) shall be imposed if job is not completed within completion period stipulated in Work Order.** Liquidated Damages shall be levied where reasons are attributable to contractors for delays in execution of order/ contract. LD shall be levied @0.5% per week or part thereof on the value of unfinished supply/work order for each week of delay subject to a maximum of 5% of the total value of contract (excluding Taxes and Duties).

10) SECURITY DEPOSIT & RETENTION MONEY

10.1 SECURITY DEPOSIT

- A. Security deposit (SD) shall be uniformly levied @ 3% of contract value towards satisfactory completion of the order/works as under.
- B. SD should be submitted in the form of Demand Draft/ Bankers' Cheque/ BG within 30 days of receipt of Letter of Acceptance or commencement of work at site whichever is earlier to materials department/ IEC/ OIC.

10.2 RETENTION MONEY

1.5% of the bill value is to be retained at the time of making payment towards rectification/defective work/supply made as retention money and be treated as Security Deposit. Therefore, the extent of Security Deposit shall be up to 3% of contract value.

10.3 REFUND OF SECURITY DEPOSIT & RETENTION MONEY

EIC/OIC shall recommend release of SD and retention money after compliance by the contractor towards guarantee/warranty/performance guarantee/defect liability period & other related clauses as stipulated in the purchase/work order and on submission of formal claim by supplier/contractor.

10.4 FORFEITURE OF SD & RETENTION MONEY

The SD & retention money shall stand forfeited in favour of UCIL, without any further notice to the contractor in the following circumstances:

- A. In case of any failure whatsoever on the part of the contractor at any time during performance of his part of the contract including the extended periods of contract, where notice is given and time for rectification allowed.
- B. If the contractor indulges at any time in any subletting/ sub-contracting of any portion of the work without approval of UCIL.

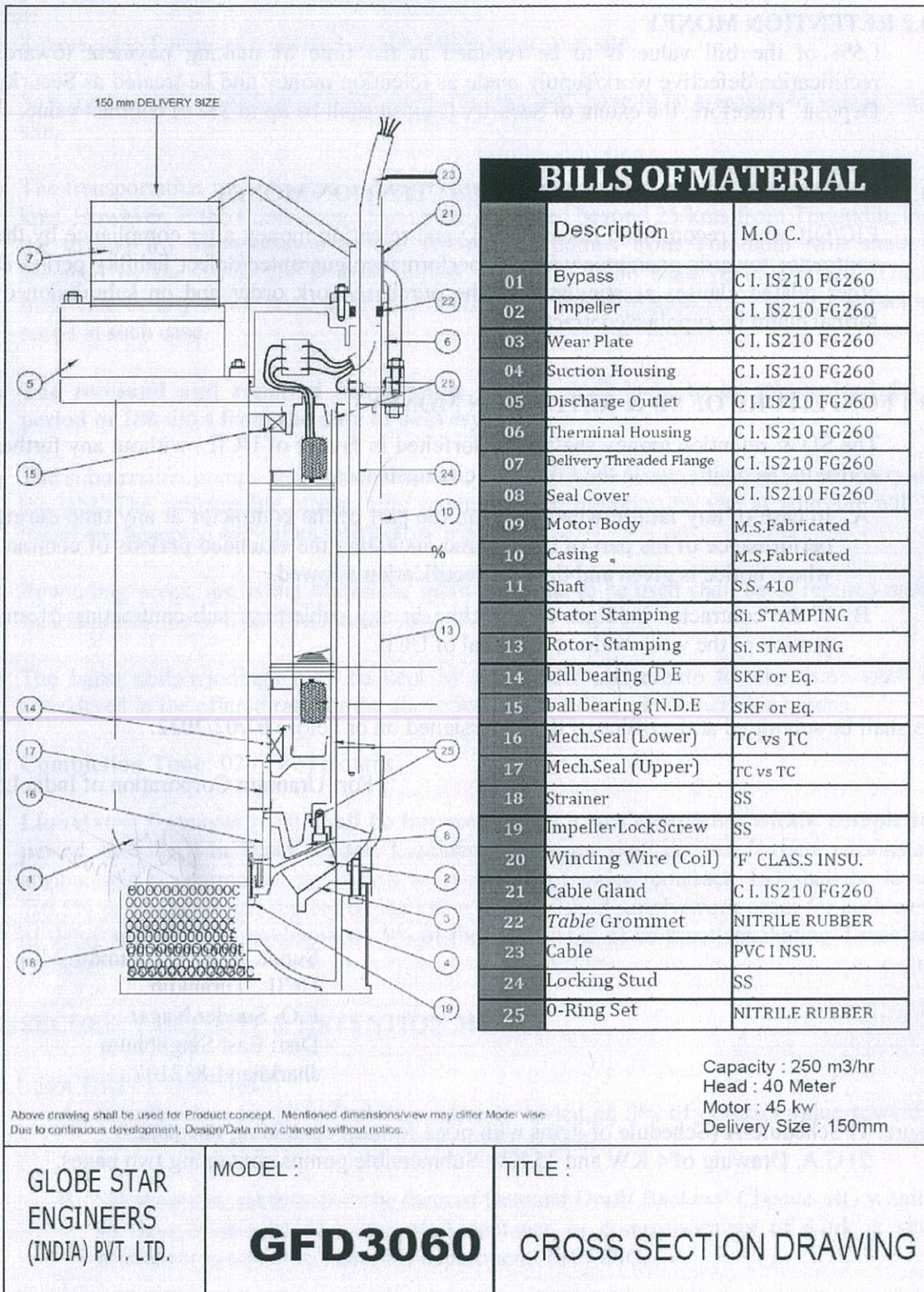

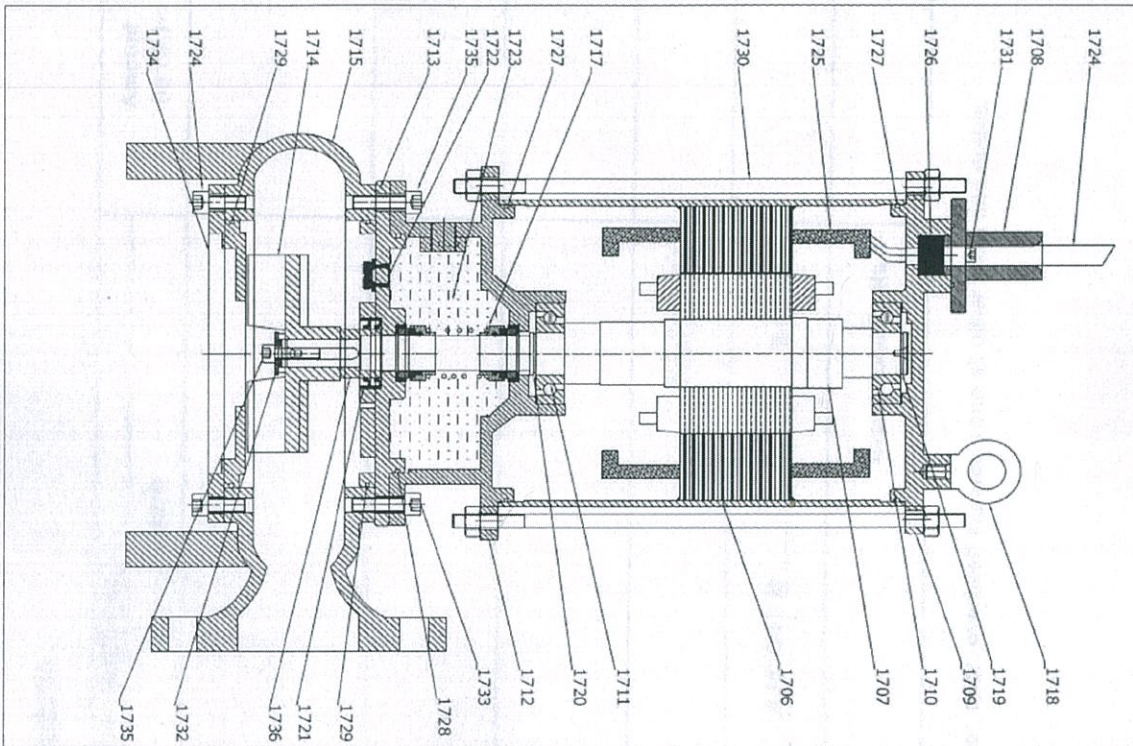
