You are requested to submit sealed quotation in duplicate for "**Cleaning and Repairing of Radiator Assembly of 500 kVA Cummins Make DG Set at Kharkai Pump House**" as per enclosed price schedule at **Schedule - A**.

The radiator assembly of the 500 kVA DG Set installed at Kharkai Intake Well Pump house, Dudra may be inspected by bidders at their own cost prior to submission of their offers.

The Radiator of our 500 KVA DG Set of Cummins Make has got damaged due to prolonged operation. The Radiator has developed leakages due to while water is getting leaked continuously during operation.

The general scope of the above job shall be as follows:

1) **Scope of Work:**

- i) Dismantling of Radiator Assembly carefully and thereafter thorough cleaning with detergent / caustic soda / any suitable non corrosive cleaning agent.
- ii) Repairing of the damaged radiator parts and making the radiator leakage proof.
- iii) Reassembling the Radiator after replacement of old gaskets with new ones.
- iv) All jobs as per enclosed schedule of items/jobs i.e. Schedule-A
- v) All items shall lie in the scope of the Contractor. No extra cost shall be entertained.
- vi) Supply of all tools and tackles and labour for carrying out all jobs as per schedule of items/jobs i.e. Schedule-A
- vii) Testing and Commissioning of the repaired radiator for 100 % leakage proof and smooth operation.

2) **Validity:** The offer shall be valid for 120 days from the date of submission.

3) **Payment:** 100% after successful testing and commissioning of the repaired radiator within 30-45 days.

- 4) **Inspection:** The radiator will be inspected during or after repairing job as and when required by us.
- 5) **Transportation:** If during carrying out the job there arises a need to transport the old radiator to bidder's workshop then UCIL shall provide the vehicle for to and fro transport of the radiator from our Kharkai Intake Well Pump House upto a distance of 50 kms only. However, the Contractor shall inform well in advance atleast 48 hours if such need arises to the Engineer-In-Charge or his representative. The loading and unloading of the Radiator at Kharkai Intake Well site and bidder's workshop shall lie in the scope of the bidder. **If the bidder's workshop is located beyond 50 kms from Kharkai Intake Well Pump House then the transport shall have to be arranged by the bidder at no extra cost.**
- 6) **Extra care shall be taken by the bidder during loading and unloading of the Radiator so that the radiator remains protected from any kind of damage. This shall be the responsibility of the bidder.**
- 7) **Guarantee:** The repaired radiator shall be guaranteed for a period of 365 days (12 months) from the date of successful trial and commissioning at our site. **This shall be treated as defect liability period of the contract.**

General terms and conditions:

- 1) Materials to be used shall be of reputed make.
- 2) **Completion time** – 15 (Fifteen) days from the date of start of the work.
- 3) **Liquidated Damages (LD) shall be imposed if job is not completed within completion period stipulated in Work Order.** Liquidated Damages shall be levied where reasons are attributable to contractors for delays in execution of order/ contract. LD shall be levied @ 0.5% per week or part thereof on the value of unfinished supply/work order for each week of delay subject to a maximum of 5% of the total value of contract (excluding Taxes and Duties).

4) SECURITY DEPOSIT & RETENTION MONEY

4.1 SECURITY DEPOSIT

A. Security deposit (SD) shall be uniformly levied @ 10% of contract value towards satisfactory completion of the order/works as under.

B. SD should be submitted in the form of Demand Draft only within 15 days of receipt of Letter of Acceptance or commencement of work at site whichever is earlier to materials department/ IEC/ OIC.

5% of the bill value is to be retained at the time of making payment towards rectification/defective work/supply made as retention money and be treated as Security Deposit. Therefore, the extent of Security Deposit shall be up to 10% of contract value.

4.3 REFUND OF SECURITY DEPOSIT & RETENTION MONEY

EIC/OIC shall recommend release of SD and retention money after compliance by the contractor towards guarantee/warranty/performance guarantee & other related clauses as stipulated in the purchase/work order and on submission of formal claim by supplier/contractor.


4.4 FORFEITURE OF SD & RETENTION MONEY

The SD & retention money shall stand forfeited in favour of UCIL, without any further notice to the contractor in the following circumstances:

- A. In case of any failure whatsoever on the part of the contractor at any time during performance of his part of the contract including the extended periods of contract, where notice is given and time for rectification allowed.
 - B. If the contractor indulges at any time in any subletting/ sub-contracting of any portion of the work without approval of UCIL.
- 5) The quoted rates shall be inclusive of material cost, labour cost, miscellaneous overheads and other taxes and duties as applicable and G.S.T. G.S.T. shall be paid only on submission of valid G.S.T. payment challan and B2B along with G.S.T Invoice/Bill.
 - 6) Quoted prices shall be firm and No escalation on any account whatsoever shall be paid against this work.
 - 7) The bidders shall submit their offers duly signed and stamped on each and every page including Price Schedule.
