You are requested to submit sealed quotation in duplicate for Supply of fire fighting crew for **28 days** in Turamdih (Mill) as per Blank Price Format (Annexure – PF).

## Scope of job:

- To provide high level of fire protection services including day to day management of the fire station, monitoring of activities, training, surprise visits and crisis management.
- Manpower of fire fighting crew performing various activities like Operation, Testing & Maintenance of trailer mounted fire pump, Fire fighting appliances viz Fire Extinguishers, breathing apparatus set, Fire-Hose, Demonstration in fire & rescue operation in plant premises as well as outside. Demonstration in Mock / Evacuation / Fire Drills and all other fire safety related activities, maintain daily check of turn out in Three Shifts and record.
- Height job, fire fighting and rescue, responsible for coordination with crew member, identify the fire hazards, participation in investigation of fire case, prepare Fire occurrence report, accounting and issue of refills and spare parts of fire fighting equipment.
- The ledger will be maintained and records updated by them. Bidder shall ensure proper stacking of refills and various items in the store and maintain bin cards separately for each item, they will conduct mock drill of fire fighting once every month, giving demonstrations on methods of using various types of fire extinguishers, maintaining the records and Time to time communication to all concern. Ensure implementation of fire preventive actions in association with safety department.
- > The crew on duty shall render all special calls, rescue calls, fire calls from township, other industries and other areas with specific permission of the company
- > Manpower required for 24 (twenty four) hours round the clock operation in 3- shifts & G-shift .
- > The bidder should have gate pass for at least 18-person as fireman and 2-person as fire officer so that 16-person could be manage on day to day basis considering off relieving system.

# Tentative fire fighting crew requirement:

- a) You shall depute fire officer and firemen for satisfactory execution of above mentioned job as per consultation of Engineer-in-charge. Average man shifts requirement shall be as below:
- b) Fire Officer will come in G Shift or as per instruction of engg-incharge. The total working days of fire officer is 28days only.
- c) Firemen required for 24 (twenty four) hours round the clock operation in 3- shifts & G-shift. The total working days of firemen is 28days.

# MINIMUM QUALIFICATION & EXPERIENCE OF PERSONNEL AND THEIR DUTIES:

Eligibility criteria of different categories of persons shall be as below. The Contractor will supply all the fire personnel, uniformed \*, trained and physically fit men . It may be relaxed in case of highly experienced/deserving candidates:

## **Commencement of work:**

The work shall commence within 10days of placement of work order.

# Period of Completion:

28 (twenty eight) days from date of commencement of the work (including Sundays).

## Payment:

1 (one) R.A. bill and Final bill shall be paid.

# **Escalation Clause**:

Escalation on Minimum wages, PF, Bonus, ESIC, etc. shall be payable as per given formula:  $E = \{R \times (W_1-W_0) \times 0.8\}/W_0$ 

Whereas, E = Escalation cost

R = Total value of bill for the month

 $W_0$  = Min. wage at the time of opening of tender  $W_1$  = Min. wage after revision for the month.

## **Insurance:**

You have to arrange Insurance (ESI) coverage for manpower engaged for the work.

#### **Award of contract:**

Contract for labour supply will be fully awarded to L1 bidder.

## Penalties:

# The Contractor will maintain the following standard of service:-

#### Attendance:

The bidder shall provide the exact number of fire service staff everyday as laid out in the contract. Attendance will be jointly certified by the contractor and the Engineer In-charge at the beginning of each shift. Failure to do so will render penalty on the contractor which will be worked out as follows:

Number of fire person less x One day salary.

Late reporting in duty will not be accepted; Firemen of the Contractor will not be taken on duty in case they report late for duty and will be marked absent calling for penalty as mentioned in 1(a).

**Turnout:** All the fire personnel provided by the Contractor will be properly turned out. The Contractor should ensure correct turnout of its fireman before deputing for duty. Improper turnout detected during attendance fall-in in the beginning of each shift will be brought to the notice of the Contractor's representative by Company's representatives. These also include hair cut and personal hygiene. Opportunity to improve the turnout and report back for duty within 30 minutes will be given. Failure to do this will be marked as absent and render penalty on the contractor which will be worked out as follows:-Number of fire person less x One day salary.

Discipline: All the fire personnel provided by the contractor will always be alert on duty. Laxity on the part of the firemen evident due to surprise checks and routine rounds by company representatives will render the firemen liable for either removal from duty or disciplinary action by the contractor depending upon the gravity of slackness. However circumstances leading to removal of firemen will call for penal deduction and render penalty on the contractor which will be worked out as follows:-

Number of fire person less x One day salary.

## Rejection of Contract:

If concerned Engineer-in-Charge finds that jobs are not being done properly and there are slackness in work or progress is not satisfactory, then reminder shall be issued to the party for the improvement and even then if not improved then contract shall be cancelled.

# Discrepancies and Adjustment of Errors:

- a. If there are varying or conflicting provisions made in any one document forming a part of the Contract, the accepting authority shall be the deciding authority with regard to the intention of the document.
- b. If on check there are found to be difference between the rates given by the Contractor in words and figures or in the amount worked out by him in the schedule of quantities and general summary the same shall be adjusted in accordance with the following rules:
  - 1. In the event of discrepancies between description in words and figures quoted by a Tenderer, the description in words shall prevail.
  - In the event of error occurring in the amount column of schedule of quantities as a result of wrong
    extension of the Unit rate and quantity, the Unit rate shall be regarded as firm & extension shall be
    amended on the basis of the rate.
  - 3. All errors in totaling in the amount column and carrying forwarded totals shall be corrected.

## Medical:

Medical fitness certificate for all employed persons from recognized doctor must be submitted to safety officer of UCIL before start and completion of the work.

### Rules and Regulations:

You have to follow all security, safety and labour rules of the Corporation.

#### **Security Deposit:**

S.D will be 3% of work order value which will be submitted at the time of contract agreement. If bidder unable to execute the awarded job then security deposit(SD) may be forfeited.

### **Terms and Conditions:**

### 1. Basis of Evaluation

Offer submitted by the bidder shall be in single part. Evaluation of L1 (Lowest) bidder shall be done based on their lowest quoted rate in totality. Bidder should quote their rate both in figures as well as in words. In case of any discrepancy in figure and words, rate written in words will be considered as final.

#### 2. Rate

Bidders shall quote rates(s) / price(s) as per price format, Annexure - PF enclosed along with Enquiry. The quoted price shall be firm for this job.

## 3. Validity

The offer shall be valid for 120 days from the date of submission of offer.

## 4. Payment

Within 28(thirty) days after submission of your clear bill in 4 (four) copies on completion of the work to the satisfaction of our Engineer in charge. Against this work order, payment may be allowed through maximum one R.A. Bill and one Final Bill.

# 5. Agreed Liquidated Damage

If successful bidder fails to execute the order within the agreed completion period, they shall be liable to pay as agreed liquidated damages a sum @1/2% of the order value per week or part thereof of delay subject to a maximum of 5%. In case of delay beyond 10 weeks. UCIL reserves the right to cancel the order and levy penalties.

# 6. Cancellation of Order

It will be your endeavour to execute the work order to our satisfaction. In case of your failure to do so, the order is liable to be cancelled.

## 7. Force Majeure

In the event of strike / lockouts, closure of work (whole or partial) breakdown of machinery, act of god or any other cause beyond our control, preventing or hindering the normal operation, we shall be at liberty to cancel this order at any time before completion of work without being liable to the bidder or other claims.

## 8. Disputes

Both parties agree in, disputes arising out of this order may be settled by arbitration, in accordance with the Indian Arbitration Act, 1940 & its subsequent amendment, by a sole arbitrator who shall be appointed by the Chairman & Managing Director of this organization (UCIL).

### 9. Jurisdiction

Any action / dispute arisen out of or from this work order shall be subject to the jurisdiction of court of law at Jamshedpur only, irrespective of anything to the contrary mentioned in the tender / quotation. Any statutory obligation has to be made by the contractor. Tenderer will extend all help.
