The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

“Similar Work” means “Experience in House Wiring, Cable Laying and Termination OR Electrical Equipment Installation / maintenance OR Street Light Maintenance / Feeder Pillar maintenance OR Sub-station installations and Commissioning / Maintenance OR Man Power supply for Electrical Work or any kind of Electrical maintenance work”.

The bidder shall submit documentary evidence by way of copy/copies of work order/Contract Agreement specifying the work & the amount of order and Work done certificate/completion certificate/Performance Certificate with executed amount and date of completion from client in support of meeting above technical eligibility criteria.
