Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. i) The Tenderer's average annual turnover for the work during last 03 years, ending 31st March of the previous financial year, should be at least Rs.4.62 of estimated value in Audited balance sheet & profit & loss account of each year must be submitted by the tenderer

ii) Experience of having successfully completed jobs during last 07 years ending last day of month previous to the one in which application are invited should be either of the following:
