  - a. Three Similar completed works costing not less than an amount equal to Rs. 88,350 /-.

or

b. Two similar completed works costing not less than an amount equal to Rs 1,10,438 /-.

or

- c. One similar completed work costing not less than an amount equal to Rs. 1,76,700 /-.
- iii) Similar type of works means Repairing / Rewinding of transformer of rating from 100 KVA upto5MVA and its H.T voltage level must be 6.6KV and above.

However in case of poor response, with a view to increase the competition, admission of additional documents to meet the Pre-Qualification Criteria may be allowed subject to the condition that

- a) 'Poor Response' implies when less than three bids are found suitable on the basis of submitted eligible documents as per NIT.
- b) The additional document should not be issued subsequent to last date of receipt of tender as mentioned in the NIT.
- c) The bidder submitting additional documents has submitted EMD and tender cost as prescribed in NIT.
- d) The opportunity of submission of additional documents will be given to all the bidders.

The Corporation reserves the right to accept or reject any or all tenders either in full or part thereof or to split up the work if necessary without arranging any reasons whatsoever.
