The extension of work beyond working hours, if any, shall be carried out after obtaining prior permission of Engineer-in-charge for which no extra claim shall be entertained.
- 3. No person shall work for more than 8 hours. In case of person has work for more than 8 hours, he shall give overtime at the rate of double his normal wages.
- 4. COMPLETION PERIOD: Total work should be completed within (60 Days), from the date of commencement of work, which shall be within 01 day from the date of issue of LOI/work order.
- 5. SAFETY: Safety precautions should be maintained during the execution of this work. All the safety appliances like helmet, safety belt, boot etc. should be provided to the workmen at your own cost.
