Dear Sir,

You are invited to offer sealed quotation for the subject work schedule of quantity in duplicate) in the enclosed schedule of quantity based on the terms and conditions given below: -

- 1. Vehicle Make, Model & Conditions of the Tractor: The Tractor trailer offered should be under the administrative control of the tenderer. The manufactured of tractor should not be earlier than January 2017. It should be in excellent condition complete with good seats, tyres & stepney etc. UCIL has the right to inspect the tractor in detail before any further processing and if the quality is not good, the tender will be rejected without assigning any reason whatsoever. UCIL will have the sole right to decide the quality of the Tractor. The Tractor trailer must have commercial registration.
- 2. Completion time of work: Total work should be completed within (04 Months), from the date of commencement of work, which shall be within 01 day from the date of issue of LOI/work order.
- 3. GOVERNMENT LABOUR ACT: The contractor has to follow strictly the Government Labour Acts, which are and will be in force during the period of execution of work. All necessary arrangements for Labour's security Insurance, will have to be made by the contractor at his own cost.
 - 4. CONTRACTOR LABOUR ACT: According to provision of contract Labour (Regulation & Abolition) Act of 1970 and Contract (Regulation & Abolition) General Rules, 1971, contractors engaging 20 or more contract labour on any day are required to obtain the license from the Regional Labour Commissioner, Chaibasa In the event of the breach of the aforesaid condition, the contractor shall be opened for action as deemed fit by the concerned labour authorities of the Central Government. E.P.F. & M.P. Act 1952 is also applicable.
 - 5. The duty of the tractor mounted with water tanker & operator is 8 hrs including Sundays and holidays.
 - 6. All taxes and any other levies etc. of the Government/ local authorities (including GST) in respect of this Contract shall be payable by the Contractor and the Corporation will not entertain any claim whatsoever in this respect.
 - 7. In case of stoppage of work by local people / Bandh or any other reasons, no idle charges will be paid by corporation towards labour, plant and machinery etc. to the contractor for this work.
 - 8. You should adjust the local labour to engage for execution of this work and to dealt with all Administrative/ local problems at their own cost.
 - 9. All the labour rules shall be followed strictly as per Contract Labour (Regulation & Abolition) Act. 1970. All registers, forms stipulated under Contract Labour under Contract Labour Act should be maintained by the contractor and to be furnished to the Corporation before commencement of the work. In case of non-submission of above registers/forms to the corporation regularly, contractor will not be allowed to continue to do the work.

- 10. You have to comply with provision of contract labour (Regulation & Abolition) Act, 1970 and rules appended there under if, applicable to him, And EPF and MP act 1952 and rules made under the said Act for their contract labours.
- 11. In case payment of labourers engaged for this work, has not been made on stipulated payment day,

 Corporation shall compel the contractor to stop the work and necessary action will be taken.
- 12. Necessary workmen insurance coverage of **01 (One) Nos. Driver (minimum)** shall be obtained by the contractor for this work at his own cost for the entire period of the contract and shall be furnished to the corporation before commencement of the work.
- 13. No extension of time will be allowed against this work on any ground.
- 14. Quantity of any individual item may vary to any extent and be excluded altogether, Contractor will carry out all works up to a total variation of ± 10% (TEN) on the contract price and all quoted rates shall remain firm within this limit.
- 15. The work will be carried out in proper condition and you shall take necessary safety precautions during the execution of work. Safety appliances like gum boot, helmet, gloves and safety belt etc. shall be provided by the contractor at their own cost.
- 16. All item rates are inclusive of all taxes, tools, tackles, barriers, danger signals, night guards, making and maintaining wherever necessary including plant and machineries.

17. Vehicle Particulars

- a) Documents: 'Registration Certificate' for excise must be obtained from the Central Excise Department. Necessary 'Road Permits', 'Road Tax Payment', 'Fitness Certificate', 'Vehicle Insurance (that should include the driver)', 'Pollution under Control Certificate' and 'other documents related to the commercial vehicles' must be kept updated and available with the tenderer. 'Periodic Brake Test and other formalities' under the Mines Act, 1952 should be carried out in time. The following documents in respect of the vehicle and the driver are to be submitted /maintained as given below.
 - b) **To be kept with the Tractor:** The following documents, viz. 'The Ownership Book', 'Up-to-date Road Tax Payment document', 'Vehicle Insurance (that should include the driver)', 'Driving License of the Driver', 'Valid Pollution under Control Certificate' and any other document that may be required as per rules should be always kept available with the driver of the vehicle on duty.
- 18. Income Tax and surcharge over Income Tax as per rules would be deducted from R. A. Bills. **PF is** applicable as per the norms of UCIL.
- 19. All the documents connected with the Tractor mounted with water tanker RC Book, Driver's License etc should always be available with the Tractor.
- 20. All the documents related to commercial Tractor mounted with water tanker must be available with the operator at all the time. Necessary Road permit for commercial Tractor must be obtained before putting tractor on duty.
- 21. Payment would be released by RTGS/e. payment. Only one RA bill & Final bill is payable for the tractor.
- 22. Operator must be well behaved or shall be suitably substituted failing which tractor shall be terminated with on-month prior notice. Accommodation for the operator is contractor's responsibility.
- 23. All the maintenance will be borne by you only.
- 24. The Engine oil, lubricant as required are to be filled up by the tenderer only and no extra charges would be paid.

- 25. There is no restriction of hours run by the tractor.
- 26. The ruling price of diesel as on the last working day of calendar month will be taken into consideration for the payment of the fuel cost. UCIL will bear the cost of Diesel calculated as given below based on actual in odometer. Tractor trailer @ 3 Ltr./Hrs

27. The contractor amount is arrived in three parts:

a) Fixed amount of tractor mounted with water tanker

b) Wages payment of driver as per actual attendance will be reimbursed by the Corporation.

c) Other is calculated on the hour meter run by the tractor mounted with water tanker as signed in the log book.

For example if the tractor has run for say 1200 hrs then the amount to be paid is fixed amount + (1200 hrs \times 3) \times Rs. 80.00/- e.g., (3 Liter @ Rs. 80.00/- Liter). Apart from this no other amount whatsoever is payable.

- 28. If the Tractor mounted with water tanker goes out of MOHULDIH the night halt charges would be Rs. 300/- per night and no other extra amount is payable. The Tractor mounted with water tanker can be sent depending on necessity if required outside Jharkhand. If tractor mounted with water tanker is retained more than duty hrs specified in the work order than an extra amount @ Rs. 50/- per hrs for water tanker shall be payable extra.
- 29. The monthly rent includes Sundays and holidays also in a month. You will be allowed to take the vehicle for repair/maintenance on one day in a month, i.e., any one Sunday subject to the convenience of the user with prior permission. For repairing/maintenance purposes the vehicle is allowed reimbursement of the maximum of 03.00 Hrs in case of Tractor trailer (tractor mounted) only including to & fro per month.
- 30. The tractor mounted with water tanker can be parked as per the direction of EIC.
- 31. The contractor must ensure that the diesel is filled to the full tank capacity. The vehicle shall be allowed to go out for filling of diesel. For the purpose of filling diesel in tank maximum ½ an hour (30 Minutes) will be allowed and odometer/hrs reading will be recorded in both cases e.g., when released and reported back. The use of Tractor for filling the diesel will be in the account of contractor.
- 32. No Escalation shall be payable under this contract.
- 33. PENALTY: In case of non availability of the vehicle due to break down, absenteeism or for any other reason attributable to the contractor, a penalty @ Rs. 3000/- per day shall be imposed if suitable substitute is not provided in time.
- 34. Quotations must be submitted in the enclosed schedule of quantity (original and two copies in Xerox of the same) duly signed along with seal of the agency. Duly filled quotations shall be submitted in a sealed envelope and to be deposited in the office of Manager (Pers.), Turamdih upto **08.03.2024** (12.00 Noon.) and will be opened on same day at 3.30 P.M at Turamdih.
- 35. All other terms and conditions shall be applicable as per General conditions of UCIL's tender

Either in full or part thereof or to split up if necessary without assigning any reason whatsoever.
