

TERMS & CONDITIONS:

1. Material must be quoted in Metric Tonne only.
2. You will quote your rate from your stock point at Haldia on landed cost basis along with price break-up as per price format.
3. Payment: Within 100% payment against Proforma Invoice.
4. Delivery shall be as & when required basis for entire tenure of quantity.
5. Party must submit density of the furnace oil for each consignment.
6. Weighment recorded at UCIL weighbridge shall be final and binding.
7. You will have to maintain a minimum stock of 150 MT at UCIL Jaduguda site, at any point of time.
8. The tankers must be supplied in properly locked and sealed condition to avoid pilferage. One key shall be deposited at Jaduguda Stores, locked shall be opened after examining the physical condition of the seal at the time of receipt of material.
9. Detail physical and chemical properties of the offered product shall be submitted along with the offer.
10. As per price format, total landed cost per MT (Rs.) in word will be considered as correct.
11. The quantity will be divided between qualified L1 & L2 bidders at the ratio of 70:30. The 30% quantity will be placed on 'L2' on event of matching of 'L1' rate (on landed cost basis), failing which the 'L3' bidder will be given opportunity to match 'L1' rate (on landed cost basis), if both 'L2' and 'L3' do not match 'L1' rate in that case balance 30% quantity will also be awarded to 'L1' bidder. If there is a tie between qualified bidders either 'L1' or 'L2'. In that case, quantity will be divided in to ratio of 50:50 on each status (i.e 'L1' or 'L2').
