- 1. Filtration test in Buckner funnel arrangement shall be carried out for evaluation of the performance of the flocculent sample. 400 ml of acidic leach slurry shall be taken in a measuring cylinder & 30m I (0.05% strength) of flocculent solution shall be mixed to it. This mixture shall be filtered through t he filter fabric fitted in the Buckner funnel under vacuum of around 475 mm of Hg. Time taken to r each the dry top of the cake must be 80-90 seconds shall be considered as filtration time. The vacuum will be continued for 30 seconds after reaching the dry top of cake on Buckner funnel, where aft er the vacuum will be cut off and moisture content in the cake will be analyzed. The flocculent sam ples which will reach the dry top of cake during the above testing within the prefix criteria of the Cor poration shall be considered qualified in the laboratory test. If the rate of filtration is faster than the above mentioned range then the particular sample shall also be qualified for further consideration provided the party complies with other Terms & Conditions of the tender.
