i) The Tenderer's average annual turnover for the work during last 03 years, ending 31st March of the previous financial year, should be at least Rs. **0.38 Lakh** in Audited balance sheet & profit & loss account of each year must be submitted by the tenderer

ii) Experience of having successfully completed for any **Hiring of Vehicle** during last 07 years in which application are invited should be either of the following:

a) One single similar completed job costing not less than **Rs. 1.03 lakhs**

or

b) Two similar completed jobs costing not less than **Rs. 0.64 lakhs each**

or

- c) Three similar completed jobs costing not less than **Rs.0.51** lakhs each.
