Only such firms need tender who can produce satisfactory evidence that they have the necessary experience & financial resources and organization to undertake such work as per criteria mentioned below.

i) The Tenderer's average annual turnover for the work during last 03 years, ending 31st March of the previous financial year, should be at least 30% of estimated value i.e. 5.20 Lakhs in Audited balance sheet & profit & loss account of each year must be submitted by the tenderer

ii) Experience of having successfully completed for "Any Civil work/Hiring of vehicle". during last 07 years ending last day of month previous to the one in which application are invited should be either of the following :

One single similar completed job costing not less than 80% of estimated value i.e. 13.87 Lakhs or

Two similar completed jobs costing not less than 50% of estimated value each i.e. 8.67 Lakhs or
