Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The eligible criteria to qualify in Technical Part are as below

1. Average Annual financial turnover during the last 3 years, ending 31<sup>st</sup> March of the previous financial year s should be at least 30% of the estimated cost i.e.Rs.**1.85** Lakhs
2. Experience of having successfully completed '**Similar works**' during last 07 years ending last day of month previous to the one in which application are invited should be either of the following:
  - a) Three Similar completed each works consisting not less than**40%** of estimated Cost or the amount equal to Rs **2.47** Lakhs or
  - b) Two Similar completed each works consisting not less than**50%** of estimated Cost or to the amount equal to Rs **3.09** Lakhs or
  - c) One Similar completed work consisting not less than **80%** of estimated Cost or the amount equal to Rs **4.95** Lakhs or
3. **Tenderer must upload relevant work order & completion certificate against each work.**
4. **Similar works means : Civil Construction work /Civil maintenance work/Sanitation work/Painting Work**
5. Bidders must attach Work done certificate mentioned executed amount and date of completion.
6. Necessary documentary evidences in support of the same in the form of copy of Work Orders & Completion Certi

ificates from the competent authority of client, along with the contact details of the signatories shall be furnished, in absence of which the offer will be rejected. Any other document / certified drawing as desired by UCIL, to assess the Similar Work shall have to be submitted.

7. (A) Public Sector Undertakings, State Government Undertakings, may be exempted from payment of EMD with the approval of Competent Authority. MSME/Small Scale Industries (SSI) with current valid registration with State or Central Govt. shall be exempted from payment of EMD (after ensuring that the registration in case of SSI pertains to the class of items/stores/works for which the tender is floated) by the authority competent to conclude supply/ contract orders.

Pre-qualification criteria with respect to prior turnover and prior experience may be relaxed for micro and Small Enterprises as per GOI guidelines subject to meeting of quality and technical specification under start up Scheme as per Govt. policy circular No. 1(2)(1)/2016-MA Dt. 10<sup>th</sup> March 2016 you have to submit NSIC certificate or other authentic relevant document to proof your capacity, quality and technical specification to qualify the technical part otherwise your tender will be not considered.

7. (B) Cost of tender fee should be paid through SBI Collect Challan. This will operate at all branches of SBI in India. Format of Challan (UCIL Copy) shall be uploaded in (**GEM Portal**) The cost of Tender may also be submitted in the form of DD in favour of Uranium Corporation of India Limited Only.
8. The tenders are to be uploaded (**GEM Portal**) on or before due date fixed for receiving the bid. Physical submission of tender shall not be accepted. Tenders received without original Earnest money deposit and cost of tender document shall be summarily rejected.
