- a)** one similar completed work costing not less than Rs 7,51,877 /-, or
- b)** two similar completed works costing not less than Rs 4,69,923 /- each, or
- c)** three similar completed works costing not less than Rs 3,75,939 /- each.

**B. Financial Criteria**

The Average Annual financial turnover during the last 3 years, ending on 31.03.2020 should be at least Rs 2,81,954 /-.

**Similar Work** means execution of Supply and Installation or Overhauling and maintenance of Cooling Tower.
