Special Terms & Conditions

2. Warranty: 12 Months from the date of supply or 18 Months from the date of installation whichever ever earlier.

After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.
