PQC CRITERIA

i) Experience of having successfully completed jobs during last 07 years ending last day of month previous to the one in which application are invited should be either of the following:-

- a) One single similar completed job costing not less than **Rs. 99.87** lakhs or
- b) Two similar completed jobs costing not less than **Rs. 62.42** lakhs each or
- c) Three similar completed jobs costing not less than **Rs. 49.94** lakhs each.
- d) The Tenderer's average annual turnover for the work during last 03 years, ending 31st March of the previous financial year, should be at least **Rs. 37.45** Lakhs in Audited balance sheet & profit & loss account of each year

ii) Similar works means and **Any Civil work/Labour supply work**

Documentary evidence in the form of Certificates from clients / Work Order copies specifying the work and the amount of contract should be submitted.

GEOGRAPHIC PRESENCE

Office registration certificate: Registered office or at least one of the registered branch office of the bidder shall be located and registered within the geographical limits of Dist - East Singhbhum, Jharkand state where the services needs to be provided. Documentary evidence must be provided in the form of Municipality trade licence or other such documents as per the following which satisfies as a proof of having the office establishment

- A) Trade licence issue by the local authority in the name of the Firm or
- B) Landline phone number in the name of the Firm or
- C) Electricity bill for last one year in the name of the Firm or
- D) GSTIN registration or
- E) Udyam /MSME /UdyogAadhaar certificate.
- F) **Office rent agreement is not acceptable/ not valid.**

PENALTY: The daily minimum deployment of labours shall be 44 (Forty four). If average monthly attendance of labour is not maintained than penalty will be made from monthly R. A bill at the rate are as follows:-

- i) If 42 Nos. average monthly labour deployment is maintained: No penalty will be deducted
- ii) If 41 to 40 Nos. average monthly labour deployment is maintained: Rs. 1000.00 penalty will be deducted for each attendance from monthly R. A bills.
- ii) If 39 to 37 Nos. average monthly labour deployment is maintained: Rs. 1500.00 penalty will be deducted for each attendance from monthly R. A bills.
- iii) If 35 Nos. & below average monthly labour deployment is maintained: Rs. 2000.00 penalty will be deducted for each attendance from monthly R. A bills

2. Forms of EMD and PBG

Bidders can also submit the EMD with Account Payee Demand Draft in favour of uranium corporation of india limited payable at JADUGUDA.
Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

3. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of uranium corporation of india limited payable at JADUGUDA. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

4. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.
